WHEREAS

Crompton shall have the right to file applications for and/or be granted patents, utility models, registered designs, design patents, and any other intellectual property rights in its own name or in the name of the Inventors or in such other name or names as Crompton may desire and the Inventors acknowledge that if any such applications are filed or rights granted in the name of the Inventors the same shall be held in trust by the Inventors for Crompton and shall at the request of Crompton be transferred from the Inventors to Crompton for no further consideration.

3. The Inventors hereby covenant with Crompton if and when required by Crompton to sign execute and do all such further documents acts or things as may be necessary or desirable to enable Crompton to procure and enjoy the full and exclusive benefit of the Invention(s) and of all rights therein including patents, design patents, registered designs, utility models or other intellectual property rights in any country of the world including if required the execution of further assignments by way of confirmation of this assignment and the execution of documents in


