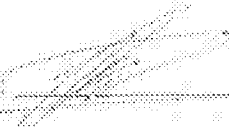
We request that the Commissioner of Patents of the United States and any official of any foreign country or countries issue any patent or patents to said company.

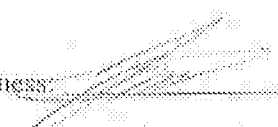
