- (1) **FARAPACK POLYMERS LIMITED** incorporated and registered in the United Kingdom with company number **05063994** whose registered office is at **The Sheffield Bioincubator, 40 Leavygreave Road, Sheffield S3 7RD (Assignor)**.
- (2) **RECKITT BENCKISER (BRANDS) LIMITED** incorporated and registered in the United Kingdom with company number **08192386** whose registered office is at **103-105 Bath Road, Slough, Berkshire SL1 3UH, United Kingdom (Assignee)**.

BACKGROUND

- (A) An Invention was made by employees of the Assignor, along with employees of Reckitt Benckiser, and the Invention is the subject of the patent application(s) as shown in Schedule 1 ("the Patent Application");
- (B) The Assignor has agreed to assign the Invention, the Patent Application and all rights therein, to the Assignee on the terms set out in this agreement.

ASSIGNMENT

In consideration of the sum of £1 (receipt of which the Assignor expressly acknowledges), the Assignor hereby assigns to the Assignee, absolutely with full title guarantee, all its right, title and interest in and to the Patent Application, and in and to all and any Invention disclosed in the Patent Application, including:

- (i) in respect of any and each Patent Application the right to claim priority from and to prosecute and obtain grant of patent and the right to file divisional applications based thereon and to prosecute and obtain grant of patent on each and any such divisional application;
- (ii) in respect of each and any Invention disclosed in the Patent Application, the right to file an application, claim priority from such application, and prosecute and obtain grant of patent or similar protection in or in respect of any country or territory in the world;
- (iii) the absolute entitlement to any patents granted pursuant to any of the applications filed as aforesaid; and
- (iv) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the Patent Applications or any patents granted on any of the applications filed as aforesaid, whether occurring before on or after the date of this agreement.

IMPROVEMENTS

If the Assignor makes, devises, or discovers, or otherwise acquires rights in, any Improvement it shall, to the extent that it is not prohibited by law or by any obligation to any other person, promptly notify the Assignee in writing, giving details of the Improvement and shall, if the Assignee so requests, enter into good faith negotiations with a view to assigning its rights in the Improvement to the Assignee.

WARRANTIES

The Assignor warrants that:

- (i) it is the sole legal and beneficial owner of the Patent Application;

- (ii) it has not assigned or licensed any of the rights under the Patent Application;
- (iii) each Patent Application is free from any security interest, option, mortgage, charge or lien; and
- (iv) it is unaware of any infringement or likely infringement of, or any challenge or likely challenge to the validity of, any of the Patent Applications or of anything that might render any of the Patents invalid or subject to a compulsory licence order or prevent any application in the Patents proceeding to grant.

FURTHER ASSURANCE

The Assignor shall, at the Assignee's cost, perform (or procure the performance of) all further acts and things, and execute and deliver (or procure the execution or delivery of) all further documents, required by law or which the Assignee requests to vest in the Assignee the full benefit of the right, title and interest assigned to the Assignee under this agreement, including:

- (i) registration of the Assignee as applicant for, or proprietor of, the Patent Application; and
- (ii) assisting the Assignee in obtaining, defending and enforcing the Patent Application.

GOVERNING LAW AND JURISDICTION

This agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of England and Wales.

This document has been executed as a deed and is delivered and takes effect on the date stated at the beginning of it.

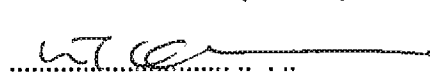

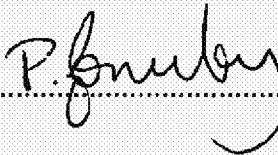

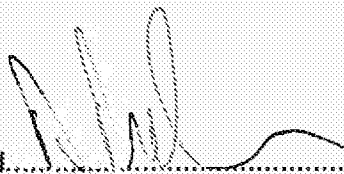
