1. The name of the corporation making the election to convert to a limited liability company pursuant to Official Code of Georgia Annotated (O.C.G.A.) Section 14-11-212 is Python Safety, Inc. (the "Corporation"), and such Corporation is organized under the laws of the State of Georgia.
