

I do hereby request and authorize that any and all LETTERS PATENT, when granted, be issued in accordance with this assignment to the Assignee.

In further consideration of the sum of Ten Euros, and the other good and valuable consideration, to me paid, I covenant and agree with the Assignee that he has a full and unencumbered title to the Invention hereby assigned, which title I warrant


unto the Assignee, and I further agree that I will, without demanding any further consideration therefor, at the request but at the expense of the Assignee, do all lawful and just acts, including the execution and acknowledgment of instruments, furnishing of information, and giving of testimony that may be or become necessary for obtaining, sustaining, or reissuing United States and foreign LETTERS PATENTS for the invention, and for maintaining and perfecting the Assignee's right to the invention and LETTERS PATENT, particularly in cases of interference and litigation.
