ASSIGNMENT

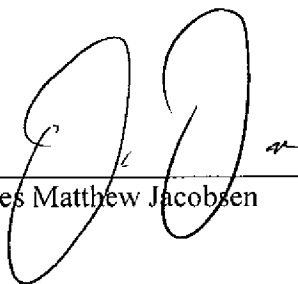

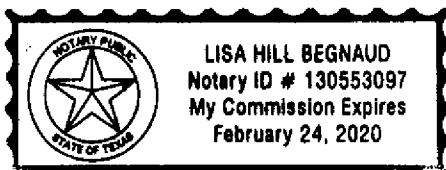

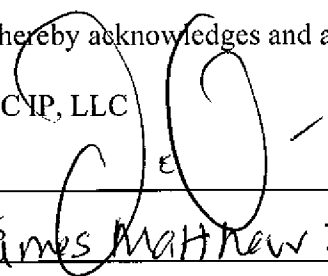
