AND for the same consideration, Assignors hereby represent and warrant to Assignee, its successors, legal representatives and assigns, that, at the time of execution and delivery of these presents, except for any rights, titles and/or interests that have arisen to Assignee under law or that have already been transferred to Assignee, Assignors are the sole and lawful owners of the entire right, title and interest in and to the said invention and application for Letters Patent above-mentioned, and that the same are unencumbered and that Assignors have good and full right and lawful authority to sell and convey the same in the manner herein set forth.

AND for the same consideration, Assignors hereby covenant and agree to and with Assignee, its successors, legal representatives and assigns, that Assignors will sign all papers and documents, take all lawful oaths and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of any Letters Patent and applications for Letters Patent for said invention, without charge to Assignee, its successors, legal representatives and assigns, whenever counsel of Assignee, or counsel of its successors, legal representatives and assigns so requests. This obligation includes providing reasonable assistance, including providing testimony in support of any Letters Patent and applications for Letters Patent related to the above-mentioned invention and Patent application for Letters Patent in any proceeding in connection with the same in any country. Such proceedings include but are not limited to proceedings before the U.S. Patent Trial and Appeal Board, the U.S. International Trade Commission, a court of law in any jurisdiction, or opposition proceedings in any jurisdiction.

AND Assignors hereby request the Commissioner for Patents to issue said Letters Patent of the United States to Assignee, as Assignee of said invention and the Letters Patent to be issued thereon, for the sole use and benefit of Assignee, its successors, legal representatives and assigns.




