- 2 No warranties of validity, non-infringement or otherwise are provided by the Assignor in relation to the Patents and the Assignor excludes all liability to the Assignee, to the fullest extent permissible by law, that may arise in relation to the Patents after the date of this Agreement, whether arising from negligence or otherwise.
  
3. No personal liability shall attach to the Liquidator in relation to this Agreement in connection with her appointment as liquidator of the Assignor.
  
- 4 To the extent reasonably practicable, the Liquidator, in her capacity as liquidator of the Assignor, shall, at the Assignee's cost, sign such documents as may be reasonably required by the Assignee to confirm the change of ownership of the Patents with the applicable national patent office.
