RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTERESTS IN PATENTS (this “Release”) is made as of October 11, 2017 (“Effective Date”) by Antares Capital LP (as successor agent by assignment from General Electric Capital Corporation) (the “Administrative Agent”) in favor of HydroChem LLC (formerly known as Aquilex HydroChem LLC) (the “Pledgor”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

WHEREAS, the Pledgor and the Administrative Agent entered into that certain Security Agreement by and between the Pledgor, the Administrative Agent and the other pledgors party thereto, dated as of December 31, 2013 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), wherein the Pledgor granted to the Administrative Agent (as administrative agent on behalf of itself and the other Secured Parties) a Lien on and security interest in all of its right, title and interest in, to and under the Pledged Collateral;

WHEREAS, pursuant to the Security Agreement, that certain Patent Security Agreement, dated December 31, 2013 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Patent Security Agreement”), was entered into by the Pledgor and the Administrative Agent to record the security interest with respect to the Patents (as defined in the Security Agreement) of the Pledgor, including those items set forth on Schedule A hereto (collectively, the “Patent Collateral”) and was recorded with the United States Patent and Trademark Office on December 31, 2013, at Reel 031893, Frame 0356; and

WHEREAS, the Pledgor has satisfied the terms of the Security Agreement and requests a specific release of the security interest granted and recorded against the Patent Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, on behalf of itself and the other Secured Parties, without recourse, representation, warranty or other assurance of any kind by the Administrative Agent (express or implied) as to the Administrative Agent’s rights in any Patents, the condition or value of any Patents, or any other matter (i) terminates the Patent Security Agreement and releases and re-assigns to the Pledgor any and all liens, security interests, right, title and interest it may have in, to and under the Patent Collateral, together with the goodwill of the business symbolized thereby; (ii) agrees that it shall execute all other documents and do all other acts reasonably requested by the Pledgor to relinquish and effect the release of such rights to the Pledgor; and (iii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Administrative Agent’s rights under the Security Agreement with respect to the Patent Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
