LEROY hereinafter referred to as Assignors have invented certain new and useful improvements in **MULTIFUNCTIONAL ACRYLIC OLIGOMERS OF BRANCHED STRUCTURE, BY POLYADDITION BETWEEN MULTIFUNCTIONAL AMINES AND ACRYLATES**, International Application No. PCT/FR2015/051575 and for which an application 15/321,023, filed December 21, 2016 for Letters Patent of the United States has been duly executed by each of us on even date herewith.



And we do hereby request and authorize the Commissioner of Patents, U.S.A., to issue said Letters Patent when granted, in accordance with this assignment.




