Pursuant to Section 242 of the
General Corporation Law of the State of Delaware

Social Communications Company, a corporation duly organized and validly existing pursuant to the General Corporation Law of the State of Delaware (the "General Corporation Law"), hereby certifies as follows:

1. The name of this corporation is Social Communications Company (the "Corporation"), and that the Corporation was originally incorporated pursuant to the General Corporation Law on September 12, 2007.
2. The Board of Directors of the Corporation has duly adopted resolutions proposing to amend the Corporation's Fourth Amended and Restated Certificate of Incorporation (the "Certificate of Incorporation") to change the name of the Corporation, declaring said amendment to be advisable and in the best interests of the Corporation and its stockholders and authorizing the officers of the Corporation to take all such actions as are necessary and proper to effect this Certificate of Amendment.
3. Accordingly, Article I of the Certificate of Incorporation is hereby amended such that the name of the corporation is hereby changed to:
