

Causes of action (whether known or unknown or whether currently pending, filed, or otherwise) and other enforcement rights under, or on account of, any of the Patents, including without limitation, all causes of action and other enforcement rights for (i) damages, (ii) injunctive relief, (iii) any other remedies of any kind for past, current and future infringement of any of the Patents, and (iv) rights to collect royalties or other payments under or on account of any of the Patents.

The terms and conditions of this Assignment will inure to the benefit of Assignee, its successors, assigns and other legal representatives and will be binding upon the Assignor, its successors, assigns, and other legal representatives.


