ASSIGNMENT

WHEREAS, Franck Olivier Lorient (the "ASSIGNOR") is the inventor and owner of the entire right, title and interest in, to, and under our United States Patent Application Serial No. 15/558,600, entitled "MOVEMENT TRANSMISSION DEVICE, IN PARTICULAR A ROBOT ARM," and the inventions described and claimed therein (collectively, the "PATENT RIGHTS"); and

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the said ASSIGNOR has sold, assigned, transferred and set over, and by these presents does hereby sell, assign, transfer and set over, unto the said ASSIGNEE, its successors, legal representatives and assigns, his entire right, title and interest in, to and under the PATENT RIGHTS and all national stage applications, divisions, renewals, continuations and continuations-in-part thereof, all applications claiming the benefit of the filing thereof, and all Patents of the United States which may be granted thereon and all reissues and extensions thereof; and all inventions described and claimed in said patents and applications; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said inventions in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said United States application under the Patent Laws of the United States, the International Convention for the Protection of Industrial Property, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of industrial property protection, including, without limitation, patents, utility models, inventors' certificates and designs which may be granted for said inventions in any country or countries foreign to the United States and all extensions, renewals and reissues thereof;

AND ASSIGNOR HEREBY authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

AND ASSIGNOR HEREBY covenants and agrees that he has full right to convey his entire interest herein assigned, and that he has not executed, and will not execute, any agreement in conflict herewith.

AND ASSIGNOR HEREBY further covenants and agrees that he will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known to him respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally provide reasonable aid to said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for said inventions in all countries.
