Further, we agree that we will, at Acumed LLC's reasonable expense, communicate to Acumed LLC, or its representatives, any facts known to us respecting the invention, and testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, reissue, substitution, and extension applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to Acumed LLC, make all rightful oaths, and generally do everything reasonably possible to aid Acumed LLC, and its successors and assigns, to obtain and enforce proper protection for the invention in the United States and in any and all foreign countries.
