*ASSIGNORS* hereby authorize and request the Patent Office Officials in the United States and its territorial possessions, and in any and all foreign countries, to issue, when granted, any and all Letters Patents thereon, and reissues thereof, to said *ASSIGNEE* as the assignee of the entire right, title and interest in and to the same, for the sole use and behalf of said *ASSIGNEE* and said *ASSIGNEE*'s successors and assigns, to the full end of the term for which said Letters Patents may be granted, as fully and entirely as the same would have been held by *ASSIGNORS* had this assignment and sale not been made; and

*ASSIGNORS* hereby authorize said *ASSIGNEE*, its successors and assigns, to file in its own name applications for patent in foreign countries in connection with the inventions hereby transferred, under the International Convention claiming the priority of said United States application or otherwise, and to secure in its own name the patent or patents issued thereon; and

*ASSIGNORS* hereby agree that, upon request, *ASSIGNORS* will sign all papers, and make all rightful oaths, and do all acts which said *ASSIGNEE*, its successors or assigns, may consider necessary in connection with said United States application, and in connection with any other United States or foreign applications that may be filed in connection with said inventions, and with any improvements thereon, and in connection with any patents issued or reissued thereon.

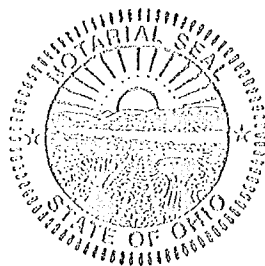

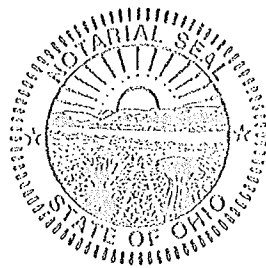
