## PATENT ASSIGNMENT AGREEMENT

THIS PATENT ASSIGNMENT AGREEMENT (this "Assignment") is made as of this 8<sup>th</sup> day of September, 2017, by DSI Assignments LLC, a Delaware limited liability corporation, solely in its capacity as assignee for the benefit of creditors of LifeHealth, LLC ("Seller") to EasyDx, Inc., a Delaware corporation ("Buyer"). All capitalized terms used but not defined herein shall have the meanings set forth in the Purchase Agreement (as defined below).

### RECITALS

WHEREAS, LifeHealth LLC ("LifeHealth") assigned its assets to Seller pursuant to that certain General Assignment for the Benefit of Creditors filed in the Second Judicial District Court for Ramsey, Minnesota as Court File No. File No. 62-CV-17-4154 on July 11, 2017;

WHEREAS, Seller and Buyer are parties to that certain Asset Purchase Agreement, dated as of August 18, 2017 (the "Purchase Agreement"), pursuant to which Seller has agreed to sell, assign, transfer, convey and deliver to Buyer, and Buyer has agreed to acquire from Seller, all right, title and interest in the Acquired Assets (as defined in the Purchase Agreement), free and clear of any Liens, including, without limitation, those patents and patent applications listed on Schedule A annexed hereto and incorporated herein by reference, and corresponding inventions, including (a) all improvements and modifications of such inventions, (b) all other applications for Letters Patent of the United States and countries foreign thereto for such inventions and all improvements and modifications thereof, (c) all Letters Patent which may issue from said applications in the United States and countries foreign thereto, (d) all divisions, continuations, reissues, and extensions of said applications and Letters Patent, (e) all post-grant proceedings including but not limited to post-grant review, ex parte reexamination and inter partes review, and (f) the right to claim for any of said applications the full benefits and priority rights under the Patent Cooperation Treaty, the Paris Convention and any other international agreement (the "Transferred Patents");

WHEREAS, Seller has agreed to execute this Assignment to evidence the transfer of the Transferred Patents to Buyer; and

NOW, THEREFORE, for and in consideration of the mutual covenants contained herein and in the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Seller hereby sells, assigns, transfers, conveys and delivers to Buyer, and Buyer hereby acquires all worldwide right, title and interest in, to and under the Transferred Patents, including all rights to sue for any damages and other remedies in respect of any infringement of any Transferred Patent, whether arising prior to or subsequent to the date of this Assignment, and all rights to claim any applicable priority rights arising from any of the Transferred Patents as may be required for any corresponding future United States or foreign patents and applications under the terms of any applicable conventions, treaties, statutes,


