And I do hereby authorize my attorneys, to insert on this deed the filing date and application number of said application when known.

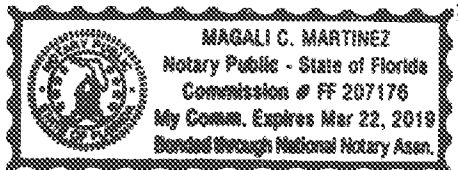
