PATENT ASSIGNMENT AGREEMENT

THIS PATENT ASSIGNMENT AGREEMENT (this "Agreement") is made and entered into as of October 18, 2017, by and between COLOR COMMUNICATIONS, INC., an Illinois corporation ("Assignor"), and CMCOLOR, LLC, a Delaware limited liability company ("Assignee").

RECITALS

- A. Pursuant to an Asset Purchase Agreement dated as of the date hereof by and between Assignor and Assignee (the "Purchase Agreement"), Assignee has agreed to purchase certain assets of Assignor, including the Assigned Patents (as defined below).
- B. Assignor is the owner of the Assigned Patents listed in Exhibit A.
- C. Assignor and Assignee desire, by execution of this Agreement, to confirm the assignment of all rights, title and interest in and to the Assigned Patents to Assignee.

AGREEMENTS

For valuable consideration, including that recited in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, and in consideration of the covenants and agreements set forth herein, Assignor and Assignee mutually agree as follows:

1. Definition of Assigned Patents. The term "Assigned Patents" means the patents listed in Exhibit A, as well as: (a) all common law rights therein; (b) all goodwill associated therewith; (c) all rights of action, powers and benefits accrued thereto, including the right to sue for and collect damages and payments for past or future infringements thereof; and (d) any derivative patent that may issue therefrom (whether known or unknown).
2. Assignment of the Assigned Patents. Assignor hereby sells, assigns and transfers to Assignee, its successors and assigns all rights, title and interest in and to the Assigned Patents.
3. Further Assurances. Assignor further agrees to take all reasonable and necessary steps to implement the provisions of this Agreement and shall provide Assignee, its successors and assigns, or their legal representatives, cooperation and assistance at Assignee's reasonable request (including the execution and delivery of affidavits, declarations, oaths, exhibits, assignments or other documentation) as may be reasonably required in the implementation of this Agreement; provided, however, that Assignor is not required to incur any costs in connection therewith. This Agreement is granted free and clear of all security interests, liens, encumbrances, claims or interests of any kind or nature, subject to Permitted Encumbrances (as defined in the Purchase Agreement).
4. Incorporation of Representations, Covenants and Warranties. Notwithstanding anything in this Agreement to the contrary, the representations, covenants and warranties, including the limitations set forth therein, of Assignor contained in the Purchase Agreement are

incorporated herein by reference. Assignor makes no representation or warranty with respect to the Assigned Patents being assigned hereby except as specifically set forth in the Purchase Agreement. If there is any conflict between the terms of this Agreement and the Purchase Agreement, the terms of the Purchase Agreement shall prevail. The parties agree to indemnify and hold harmless one another for violations of this Agreement as provided in the Purchase Agreement, subject to the limitations provided therein.

5. Governing Law. This Agreement shall be governed by the laws of the State of Delaware and the federal laws of the United States without giving effect to any rule or provision thereof that would cause the application of the law of any other state.

6. Electronic Signature; Counterparts. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which, together, shall constitute one and the same instrument. A copy of this Agreement transmitted via facsimile or e-mail (e.g., pdf or tif file) bearing the signature of any party shall be deemed to be of the same legal force and effect as an original of this Agreement bearing such signature as originally written of such party.


