ASSIGNMENT

WHEREAS, I, **TIANXIAO ZHANG**, 95 Tianhe Road, Tianhe Building, Room 402, Taizhou, Jiaojiang, Zhejiang Province, 318000, China, have invented certain new, useful, and ornamental improvements in a **QUICK RELEASE HAMMOCK FRAME**, for which a Chinese utility application was filed on October 28, 2016 and assigned application number 201621188918.4 and Chinese design application was filed on November 1, 2016 and assigned application number 201630521987.1 (the "Priority Applications").

NOW THIS INDENTURE WITNESSETH, that for the sum of one dollar and other valuable consideration to me in hand paid, the receipt of which is hereby acknowledged, I hereby assign, sell, and transfer unto the **VIVERE LTD.** my entire right, title, and interest in said improvements, said application, and all national phase, divisional, continuing, substitute, renewal, reissue, and all other applications for Letters Patent which have been or shall be filed in the Conveyed Territories on any of said improvements; and in and to all original and reissued patents which have been or shall be issued in the Conveyed Territories on said improvements; and in and to any and all priority rights, rights under the International Convention For The Protection Of Industrial Property, rights under the Patent Cooperation Treaty, and other benefits accruing or to accrue to me with respect to the filing of applications for patents or securing of patents in the Conveyed Territories.

And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said Letters Patent in the Conveyed Territories to said **VIVERE LTD.** as the assignee of my whole right, title, and interest thereto.

And I further agree to sign and properly execute such necessary and lawful papers for application for patents, for filing subdivisions of said application for patent, and for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid improvements in the Conveyed Territories, as the assignees thereof shall hereafter require and prepare at its own expense.
