#### RELEASE OF SECURITY INTEREST IN PATENTS

- 3. <u>Termination</u>. The Agent hereby terminates and cancels the Patent Security Agreement, and the Patent Security Agreement shall have no further force and effect.
- 4. <u>Governing Law</u>. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
