AND ASSIGNORS, on behalf of themselves and their heirs, executors and administrators, do hereby covenant and agree to do all such lawful acts and things and to execute and deliver without further consideration such further lawful assignments, instruments, assurances, applications and other documents

as may reasonably be required by said Assignee, or by its successors, assigns, nominees, or other legal representatives, to obtain each said Letters Patent and Registrations of the United States and all other countries and jurisdictions for the Invention and vest or secure the same in Assignee, and in Assignee's successors, assigns, nominees or other legal representatives.

AND ASSIGNORS do hereby authorize any official whose duty it is to grant patents or registrations, to grant each said Letters Patent and Registration for the Invention to the Assignee, and to Assignee's successors, assigns, nominees or other legal representatives.

AND ASSIGNORS, on behalf of themselves and their heirs, executors and administrators, do hereby authorize said Assignee, its successors, assigns, nominees or other legal representatives, including its Patent Agents, Norton Rose Fulbright Canada LLP, to amend the present assignment document to insert or correct the filing date, serial number or other identifying information of the Application as may be needed to record same.
