PATENT ASSIGNMENT

This Patent Assignment ("Assignment") is entered into as of July 2, 2013, by and between Qwiki, Inc., a Delaware Corporation (the "Company"), having an address at 113 Spring Street, 3rd Floor, New York, New York 10013, and Yahoo! Inc., a Delaware Corporation ("Yahoo!"), having an address at 701 First Avenue, Sunnyvale, CA, 94089.

NOW, THEREFORE, pursuant to the Merger Agreement, and for good and valuable consideration given and received, the receipt and legal sufficiency of which is hereby acknowledged, the Company and Yahoo! agree as follows:

The Company hereby:

- (A) irrevocably transfers, conveys and assigns to Yahoo!:
 - (1) the entire right, title and interest, everywhere in the world to
 - (a) all patents and patent applications owned by the Company, including, without limitation, the issued patents and patent applications set forth in Exhibit 1, and any patents later granted on the patent applications set forth therein,
 - (b) any patent applications or patents claiming priority to the items in (a) (including, but not limited to, continuations, divisions, continuations-in-part, substitutes, reissues, reexaminations, extensions and renewals thereof, together with all priority rights and counterpart applications under any existing or future international patent conventions, agreements or treaties),
 - (c) any patent applications or patents to which any of the patents or patent applications in (a) or (b) claim priority and any foreign counterparts to any patents or patent applications in (a) or (b),
 - (d) any other rights in the inventions described or disclosed in any of the patents and patent applications in (a), (b) or (c);

(all of the foregoing in (1), collectively, the "Assigned Patents");

- all rights to causes of action and remedies related to the Assigned Patents, including without limitation the right to sue third parties for past, present or future infringement (including, but not limited to, damages and injunctive relief) of any of the Assigned Patents; and
- (3) all rights to receive royalties with respect to the Assigned Patents; and
- (4) any and all other rights and interests arising out of, in connection with or in relation to the Assigned Patents.
- (B) agrees, without further compensation, upon request of Yahoo! (or its successors, assigns or legal representatives) to:
 - (1) execute any and all oaths, assignments, powers and any other papers;

- (1) execute any and all oaths, assignments, powers and any other papers;
- (2) testify in any and all proceedings; and
- (3) otherwise take any and all actions, and fully cooperate with Yahoo!; in each case, as may be necessary or appropriate, in the opinion of Yahoo!, to convey, establish, evidence, maintain, defend and enforce Yahoo!'s rights in the Assigned Patents or otherwise related to securing and enforcing Yahoo!'s rights under this Assignment; and Company hereby irrevocably appoints Yahoo! and any of its officers as Company's attorney in fact to undertake such acts in Company's name; and
- (C) agrees to deliver to Yahoo! accurate copies of all material correspondence with counsel, in the Company's or its counsel's possession, relating to ownership, filing, prosecution, infringement, validity, or enforceability of, the Assigned Patents, to the extent such has not already been delivered.


