WHEREAS, ASSIGNOR believes himself or herself to be the original inventor or an original joint inventor of the subject matter claimed in said patent application; and



assigns, to obtain and enforce proper patent protection for said inventions in the United States of America and elsewhere throughout the world.

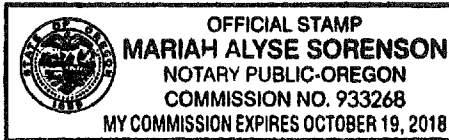
