PATENT ASSIGNMENT

Assignors further agree at any time to cooperate with Assignee, and to execute and to deliver upon request of the Assignee such additional documents, if any, as are necessary or desirable, in the prosecution of the Patents, and to secure patent protection on said inventions, discoveries and applications throughout all countries of the world, and otherwise to do such acts as are necessary to give full effect to and to perfect the rights of the Assignee under this Assignment, including the execution, delivery and procurement of any and all further documents evidencing this assignment, transfer and sale as may be necessary or desirable. In the event that Assignors are unable or unwilling to do so, the Assignors hereby authorize the Assignee, or the Assignee's attorney or agent, to execute on Assignor's behalf substitute statements or other documents required for obtaining, perfecting, sustaining, and/or enforcing the Patents.
