ASSIGNMENT OF INVENTION AND PATENT APPLICATION

Assignor further agrees to: (a) execute the prosecution of the Design Patent Application; (b) perform such other acts as Assignee lawfully may require to obtain or maintain the Design Patent at the United States Patent and Trademark Office.
