

TO BE HELD AND ENJOYED BY Assignee, its successors and assigns, to the full ends of the respective terms for which the registered designs have been or may be registered and for which the letters patents have been or may be granted, as fully and entirely as the same would have been held and enjoyed by Assignor had this sale and assignment not been made.

6. AND Assignor hereby authorizes and requests the applicable intellectual property office to register any and all registered designs or issue any and all letters patent which may be applicably registered or granted in respect of the IP Rights to Assignee, its successors and assigns.


