FOR SAID CONSIDERATIONS, we hereby covenant and agree that we are the owner of the full title herein assigned and have the right to assign the same, and agree that we will communicate to said corporation or its representatives, any facts known to us respecting said invention or inventions and testify in any legal proceedings relating thereto when called upon, and, on behalf of ourselves and our legal representatives and successors, will sign all instruments and documents and render such assistance which in the judgment of said corporation is necessary to vest in it and protect the legal title sought to be assigned, including, but not limited to, the execution of a declaration for an application filed under 35 U.S.C. 111(a) based on or claiming priority of said provisional application.


