ASSIGNMENT OF PATENT RIGHTS

THIS ASSIGNMENT OF PATENT RIGHTS (the "Assignment") is made and entered into this 10 day of September 2011, by and between American Coating Technology, Inc., a corporation organized and existing under and by virtue of the laws of the State of Wisconsin ("Assignor") and Jodi A. Schwendimann, residing at 3230 Bohms Point Lane, Orono, MN 55331 (hereinafter "Assignee"). Assignor and Assignee may be referred to in this Assignment individually as "Party" and collectively as "Parties."

RECITALS

WHEREAS, Assignor owns all right, title and interest in and to the patents and patent applications described on Schedule 1 attached hereto, and all inventions and improvements disclosed in the aforesaid patents and applications, including any and all rights, priorities and privileges provided under United States, state or foreign law or multinational law, compact, treaty, protocol, convention or organization, or other legal protections or related rights that are or may be secured in any jurisdiction anywhere in the world with respect to the foregoing (collectively, the "Patents"); and

WHEREAS, Assignor has agreed to assign to Assignee and Assignee has agreed to accept the assignment of all rights in the Patent Rights (as defined below).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties mutually agree as follows:

Assignor does hereby sell, assign, convey, transfer and deliver to Assignee all right, title and interest in and to all of the following rights and property interests, the same to be held and enjoyed by Assignee, its successors and assigns to the same extent that it would have been held and enjoyed by Assignor if this Assignment had not been made: (i) the Patents; (ii) all divisions, continuations, continuations-in-part, continued prosecution applications, provisional applications, utility models, petty patents, and all Letters Patent which may be granted from the Patents; (iii) all revalidations, renewals, reissues, reexaminations, or extensions of the foregoing; (iv) any and all applications that have been or shall be filed in any foreign countries for Letters Patent on any of the foregoing, including an assignment of all rights under the provisions of the International Convention, and all foreign counterparts of any of the foregoing related and registrations pertaining thereto; (v) all income, royalties, damages, and payments now or hereafter due or payable with respect to the foregoing; (vi) all causes of action (in law or equity) and rights to sue, counterclaim and/or recover for past, present or future infringement with respect to the foregoing; and (vii) all rights throughout the world corresponding to the foregoing (collectively, the "Patent Rights").

Assignor hereby authorizes the United States Patent and Trademark Office and/or the appropriate empowered officials in relevant jurisdictions outside the United States to transfer all ownership rights in and to the Patent Rights to Assignee as assignee of the entire right, title and interest therein or otherwise as Assignee may direct, in accordance with this instrument of assignment. Assignor will take, or cause to be taken, all such other and further actions as may be required by Assignee to effect the assignment contemplated hereby, or which may be necessary or desirable more effectually to secure to and vest in Assignee, her heirs and assigns the entire right, title and interest in and to the Patent Rights hereby assigned and conveyed, or intended so to be.

Assignor warrants and covenants to Assignee, her heirs and assigns, that no assignment, grant, mortgage, license or other agreement affecting the Patent Rights herein conveyed has been made to others by the Assignor, and that Assignor has the full right to convey the same as herein expressed.
