THIS DEED is made on the 21ST day of FEBRUARY 2017

BETWEEN

("Assignor")

AND

833 ENTERPRISES PTY LTD, (ACN 613 357 841) of Unit 1, 288 Victoria Road, Malaga, Western Australia 6090, Australia.
("Assignee")

RECITALS:

- A. The Assignor is the proprietor of intellectual property comprising Patents and Trade Marks which are the subject of Patent and Trade Mark Applications and Registrations, and related copyright ("the Intellectual Property") as identified in the Schedule to this Deed.
- B. The Assignor has agreed to assign all their right, title and interest in and to the Intellectual Property together with any copyright pertaining thereto, together with the goodwill associated with the Assignor's trade in the goods and services in respect of which the Trade Marks have been used, to the Assignee.

NOW BY THIS DEED

1. ASSIGNMENT

In consideration of the payment of AU\$10.00 by the Assignee to the Assignor, and for other good and valuable consideration, receipt of and sufficiency of which is hereby acknowledged, the Assignor does hereby sell, assign and transfer to the Assignee, all their right, title and interest to and in the Intellectual Property and the Applications and Registrations, the right to gain registration of the Intellectual Property in the Assignees name, and the right to apply to register and to gain registration of the Intellectual Property in other jurisdictions; together with the copyright pertaining to any artworks relating to and depicting the Intellectual Property and product packaging for product marketed under the Intellectual Property, including copyright subsisting in drawings artwork literature and microprocessor/microcontroller code all pertaining to product related to the Patents and Trade Marks, together with the goodwill associated with the Assignor's trade in the goods and services in respect of which the Intellectual Property has been used.

2. WARRANTIES

The Assignor warrants that:

- a) they have absolute title to the Intellectual Property;
- b) there are no outstanding encumbrances or other matters affecting their capacity to assign the Intellectual Property; and
- c) the Assignor has no knowledge of any prior use of the Intellectual Property by any other party.

3. FURTHER ASSURANCES

The Assignor undertakes and agrees to execute and deliver all such documents and other instruments as may be necessary to:-

- a) enable the Assignee to apply for and obtain registration as the registered proprietor of the Intellectual Property; and
- b) cancel the registration of any registered user of the Intellectual Property.

4. COSTS

The costs of and incidental to the preparation, execution, stamping and registration of this deed shall be paid by the Assignee.

5. GOVERNING LAW

The Deed and the respective rights, duties and obligations of the parties hereunder shall be governed by and constructed in accordance with the law of the State of Western Australia.




