DEED OF ASSIGNMENT

This Deed of Assignment is made on 21 August 2017 by and between

Leo LIU whose domicile is 36-601, Lane 100, Wending Road, Minghang District, 201104, Shanghai, China;

("Designer")

and

Philips Lighting Holding B.V., a company incorporated under the laws of The Netherlands, having its registered office at High Tech Campus 45, 5656 AE Eindhoven, The Netherlands ("Philips Lighting").

Whereas:

Designer has undertaken to create certain new designs for industrial products for Philips Lighting and Designer has delivered to Philips Lighting certain design(s) as specified in Annex A (these designs, together with all sketches, intermediary materials and related artwork are hereinafter referred to as "the Designs").

Now therefore, the Designer hereby confirms as follows:

1. Designer hereby assigns to Philips Lighting all Designer's right, title and interest in and to the Designs, including all design rights, copyrights and all other intellectual property rights, for the full duration of such rights, on a worldwide basis.
2. Philips Lighting (and not Designer) shall be entitled to apply for registration of any intellectual property rights in relation to the Designs in any and all jurisdictions, as well as the right to claim the relevant priority under article 4 of the Paris Convention.
3. Philips Lighting shall be free to deal with the Designs howsoever in its entire discretion, including without limitation, the right to modify or change the Designs and the right to create two-dimensional representations or three-dimensional embodiments thereof.
4. Philips Lighting shall not be obliged to commercialize the Designs, nor to use Designer's name in connection with the Designs or the exploitation thereof.
5. At the request and expense of Philips Lighting, Designer shall provide all assistance and execute all documents that Philips Lighting may require in connection with the registration, maintenance, defense and enforcement of its rights in the Designs. Designer hereby authorizes Philips Lighting to appoint representatives to act on Designer's behalf in connection with the registration of the Designs.
6. Designer has received appropriate compensation from Philips Lighting (or any of Philips Lighting's affiliates) in respect of the creation of the Designs and this assignment. Designer will not be entitled to any additional compensation in connection with the exploitation of the Designs by Philips Lighting, Philips Lighting's affiliates, assignees, licensees or other nominees.
7. This Deed of Assignment cannot be rescinded or revoked.

8. This Deed of Assignment shall be governed by and construed in accordance with Dutch law. Any disputes are exclusively settled by the competent courts in The Hague, The Netherlands.

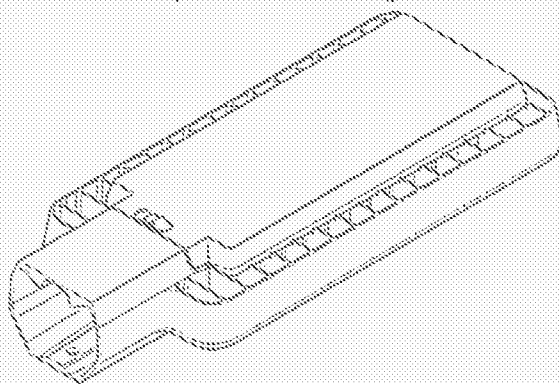

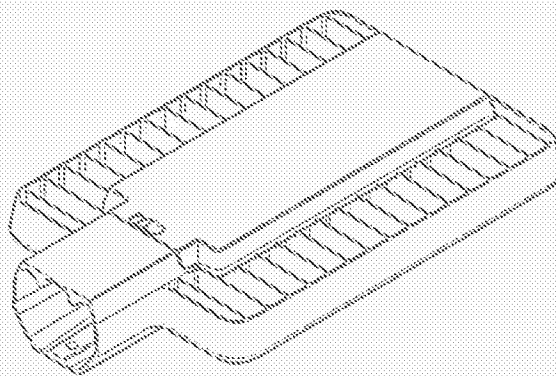

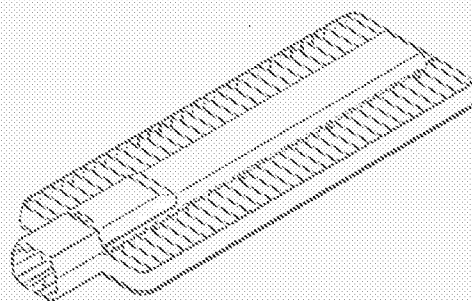
