

Assignor and Assignee agree and confirm that Assignor conveyed, assigned, and transferred the Assignor's entire right, title and interest in US Patent Application Nos. 13/504,179, 13/504,201 and 13/504,189 (the Patent Applications), which have since matured into U.S. Patent Nos. 8951176, 9387994, and 9302929, respectively (hereinafter "the Patents"), to Assignee in a transfer agreement (hereinafter "the Transfer Agreement") having an effective date of 22 December 2014 (hereinafter "the Effective Date"). Assignor further covenants that Assignor will testify on behalf of Assignee, its successors and assigns in any legal or administrative proceeding involving one or more of the Patents and generally do everything possible to aid Assignee, its successors and assigns in obtaining, defending and enforcing these Patents. This includes both communicating all facts known respecting the Patents and signing and delivering any and all papers, instruments or affidavits required to maintain, defend or enforce one or more of the Patents.
4. The transfer under the Transfer Agreement was based on consideration for money received and/or other good and valuable consideration. Assignor hereby acknowledges receipt of the above-mentioned consideration.
5. This agreement is effective as of the Effective Date.
6. This agreement is governed by the law of the District of Columbia, USA. In case of any controversies, including the validity, construction or performance of this Agreement, the District Court for the District of Columbia, USA, shall have exclusive jurisdiction. In the event that any clause in this agreement is found invalid by a court of law, the parties agree that the remainder of this agreement should be upheld to the extent possible to effectuate the purpose of this agreement.
