Whereas, this Assignment is being executed by Assignor to Company in accordance and consistent with the Settlement Agreement entered into by the Parties on October 13, 2017.



Assignor Hereby represents and warrants that it has the full legal right and authority to convey the entire interest herein assigned, and that Assignor has not executed, and will not execute, any agreement in conflict herewith; and

Assignor Hereby further covenants and agrees that, without further compensation, it (i) shall take all acts reasonably requested of it to document and implement this Assignment, (ii) within fourteen (14) days of any written request, which shall be sent to Robert Neal at robertwneal@yahoo.com and to Michael Garin at mike_garin@yahoo.com, it shall sign all documents required by Company to transfer and assign the Patents hereunder, and to verify the validity of this Assignment.


