MPT hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to issue a Letters Patent upon any such division, extension, continuation, re-examination, or reissue, to MPT and SCI as joint owners with undivided rights, title and interest therein, for the use and behalf of MPT and SCI without accounting to each other, their successors, assigns, and legal representatives, to the full end of the term for which the Letters Patent may be granted, the same as they would have been held and enjoyed by MPT had this assignment not been made.
