representatives and assigns, to the full end of the term or terms for which Letters Patent may be granted and/or extended, as fully and entirely as the same would have been held and enjoyed by Assignors, had this sale and assignment not been made.

AND Assignors hereby assign all their rights and interests therein insofar as European Patent Office is concerned to Assignee, and do hereby authorize Assignee to apply for and obtain Patent rights for the said invention in its own name in European Patent Office in accordance with this assignment.
