ASSIGNMENT

PARTIES

- (1) **Element Six South Africa (Pty) Limited** a company registered in South Africa under company number 1961/000001/07 of 1 Debid Road, Nuffield, Springs, South Africa, previously known as Element Six (Pty) Limited ("the ASSIGNOR")
- (2) **Element Six (Production) (Pty) Limited** a company registered in South Africa under company number 1960/004396/07 of 1 Debid Road, Nuffield, Springs, South Africa ("the ASSIGNEE")

DEFINITIONS

- A. "APPLICATION" shall mean, jointly and severally, the patent applications and patents set out in the Schedule to this assignment.
- B. "INVENTION" shall mean the invention to which the APPLICATION relates.
- C. "EFFECTIVE DATE" shall mean the date of invention of the INVENTION.

WHEREAS

1. At the EFFECTIVE DATE the ASSIGNOR was known as De Beers Industrial Diamonds (Pty) Limited.
2. From the EFFECTIVE DATE until 1st September 2006, the ASSIGNOR was the legal owner of the INVENTION and the APPLICATION.
3. On 1st September 2006, the ASSIGNOR (when known as Element Six (Pty) Limited) sold the entire of its undertaking business assets and liabilities to the ASSIGNEE.
4. The business assets of the ASSIGNOR on 1st September 2006 included the INVENTION and the APPLICATION.
5. The parties have agreed to execute this Assignment for the purposes of ensuring that all legal rights in the INVENTION and the APPLICATION and all other intellectual property rights relating thereto are vested in the ASSIGNEE and to confirm the ASSIGNEE's title to the same.

IT IS AGREED THAT


In consideration of the payment of US\$1 (one US dollar) paid by the ASSIGNEE to the ASSIGNOR, receipt of which is hereby acknowledged:

- (a) The ASSIGNOR confirms the assignment of, and as necessary assigns to the ASSIGNEE, from the EFFECTIVE DATE, all right title and interest in and to the INVENTION and the APPLICATION and the ASSIGNEE confirms its acceptance of, and as necessary accepts, from the EFFECTIVE DATE, the right title and interest in and to the INVENTION and the APPLICATION including without limitation:
 - (i) the right to apply for and obtain patents in respect of the INVENTION in any country in the world;
 - (ii) all right title and interest in the APPLICATION and all patent applications, patents and supplementary protection certificates which may now or at any time in the future derive or result or claim priority from the same or otherwise relate to the INVENTION, including any divisionals, continuations, reissues, re-examination certificates, extensions, renewals and registrations in relation to any thereof and all and any other rights in the inventions comprised in any of the same (hereinafter collectively and severally "the PATENT RIGHTS");

- (iii) the benefit of all priority dates;
 - (iv) the right to seek and to obtain registrations in any country in the world in respect of any patent deriving from the APPLICATION or otherwise included in the PATENT RIGHTS;
 - (v) the right to sue for and obtain injunctive relief, damages and all other relief in respect of any infringement or misuse (whether past present or future) of any of the PATENT RIGHTS or of the rights conferred by the publication of any of the same.
- (e) The ASSIGNOR hereby agrees to execute all such documents and do all such things as may be required by the law of any country in order to record the APPLICATION and any other PATENT RIGHTS in the name of the ASSIGNEE.
- (f) This Assignment shall be governed by English law, and the parties submit to the exclusive jurisdiction of the English courts in respect of any dispute relating to this Assignment.


