## ASSIGNMENT OF INVENTION AND LETTERS PATENT

We do hereby request and authorize the Director of the United States Patent and Trademark Office, to issue said Letters Patent when granted, in accordance with this assignment.

We further covenant and agree with the ASSIGNEE that we have a full and unencumbered title to the invention herein assigned, which title we warrant unto the ASSIGNEE, and we, the undersigned ASSIGNORS, further agree that we will, without demanding any further consideration therefor, at the request but at the expense of the ASSIGNEE, do all lawful and just acts, including the execution and acknowledgment of instruments, that may be, or become necessary, for obtaining, sustaining or reissuing United States or foreign Letters Patent for the said invention, and for maintaining and perfecting the assignee's right to said invention and Letters Patent, particularly in cases of interference, derivation proceedings and litigation.




