**DEED OF ASSIGNMENT**

**THIS DEED OF ASSIGNMENT** is made on the 26<sup>th</sup> day of May 2017

**BETWEEN**

- (1) **JOHNSON MATTHEY PUBLIC LIMITED COMPANY** (the "Assignor") a company incorporated and registered in England with company number 33774, the registered office of which is at 5<sup>th</sup> Floor, 25 Farringdon Street, London EC4A 4AB, England signing on its own behalf and as agent for and on behalf of each member of its Group; and
- (2) **JOHNSON MATTHEY FUEL CELLS LIMITED** (the "Assignee") a company incorporated and registered in England with company number 04393161, the registered office of which is at 5th Floor, 25 Farringdon Street, London EC4A 4AB, England

(Parties (1) and (2) being referred to in this Agreement together as "the Parties" and each as a "Party").

**WHEREAS**

- (A) Assignor is the registered sole or joint proprietor of the patents, patent applications and trademark registrations listed in Annex 1 (hereinafter the "Intellectual Property Rights");
- (B) Assignor and Assignee have agreed that Assignor shall transfer ownership of the Intellectual Property Rights to Assignee;

NOW THEREFORE, THIS DEED WITNESSES that in consideration of the premises and the mutual covenants and agreements hereinafter contained and other good and valuable consideration (the receipt and sufficiency of which is hereby acknowledged), the parties agree as follows:


- (1) Assignor hereby assigns with full title guarantee its respective right, title and interest in the Intellectual Property Rights to Assignee as well as the benefit of any and all statutory and common law rights attaching thereto.
- (2) The rights assigned under Clause 1 includes all rights, powers and benefits arising from and accrued to the Intellectual Property Rights including the right to sue for damages and other remedies in respect of any infringement of such rights prior to the date of this Assignment and any damages obtained as a result of such action.
- (3) The Assignor covenants that, at the request of the Assignee, it shall do all such further acts and execute all such documents as may be reasonably necessary or reasonably desirable both to secure the proper vesting in the Assignee of all rights assigned to the Assignee and to assist in the resolution of any question concerning the Intellectual Property Rights.
- (4) It is hereby agreed between the Parties that
  - (a) Assignor will register Assignee as the owner of the Intellectual Property Rights and the costs incurred in connection with the registration of Assignee as owner of the Intellectual Property Rights shall be met by Assignor; and
  - (b) From the date of this assignment or from the date that Assignee is registered as owner of the Intellectual Property Rights, whichever is later, Assignee will assume responsibility for


the prosecution and maintenance of the Intellectual Property Rights. Assignee shall meet the cost of prosecuting and maintaining the Intellectual Property Rights.

- (6) This Agreement shall be governed by English law and the parties hereto submit to the exclusive jurisdiction of the English courts.


