




WITNESSETH

ARTICLE 4


ASSIGNMENT OF RIGHTS

registered and unregistered trademarks.


4.2 In consideration of the mutual covenants set forth herein and for other good and valuable consideration, the adequacy, receipt and sufficiency of which are hereby acknowledged, the Members hereby acknowledge that all Intellectual Property in the swimming pool skimmer, as that invention exists at the effective date of this Agreement, as well as all Intellectual Property that has been or will be made, created, authored, conceived, discovered, reduced to practice or developed by a Member as a result of any work performed by a Member on behalf of the LLC or on behalf of any predecessor to the LLC shall belong to the LLC. Each Member hereby assigns to the LLC the entire right, title and interest to the swimming pool skimmer and all Intellectual Property that has been or will be made, created, authored, conceived, discovered, reduced to practice or developed by a Member as a result of any work performed by a Member on behalf of the LLC or on behalf of any predecessor to the LLC.

4.3 At the request of the Majority of Members, a Member shall cooperate in all lawful acts which may be desirable or necessary in the judgment of the Majority of Members to protect for the LLC all such Intellectual Property. The obligations of this Article 4.3 shall survive dissociation of any Member.
