



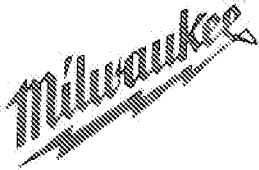

EMPLOYEE AGREEMENT
