(Pursuant to Section 253 of the General Corporation Law of Delaware)

Harris Corporation, a corporation incorporated on the 6th day of December 1926, pursuant to the provisions of the General Corporation Law of the State of Delaware (“Survivor”),

DOES HEREBY CERTIFY that Survivor owns 100% of the capital stock of Exelis Inc., a corporation incorporated on the 4th day of May 2011, pursuant to the provisions of the Indiana Business Corporation Law (“Subsidiary”), and that Survivor, by a resolution of its Board of Directors duly adopted on December 4, 2015, determined to merge Subsidiary into itself, to be effective as of 11:59:59 p.m. on December 31, 2015, which resolutions are in the following words to wit:

WHEREAS, Harris Corporation, a corporation incorporated under the laws of Delaware (“Survivor”), lawfully owns 100% of the outstanding stock of Exelis Inc., a corporation incorporated under the laws of Indiana (“Subsidiary”); and

WHEREAS Survivor desires to merge Subsidiary into itself, to be effective as of 11:59:59 p.m. on December 31, 2015, and to be possessed of all the estate, property, rights, privileges and franchises of Subsidiary; and

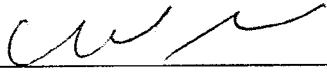
NOW, THEREFORE, BE IT RESOLVED, that Survivor shall merge Subsidiary into itself, to be effective as of 11:59:59 p.m. on December 31, 2015, and shall assume all of Subsidiary’s liabilities and obligations, and

FURTHER RESOLVED, that any authorized officer of Survivor be, and he or she hereby is, directed to make and execute a certificate of ownership setting forth (i) a copy of the resolution to merge Subsidiary into Survivor and assume Subsidiary’s liabilities and obligations, and (ii) the date of adoption thereof, and to file the same in the office of the Secretary of State of Delaware, and a certified copy thereof in the office of the Recorder of Deeds of New Castle County; and

FURTHER RESOLVED, that the officers of Survivor be, and each of them hereby is, authorized and directed to do all acts and things whatsoever, whether within or without the State of Delaware; which may be in any way necessary or proper to effect said merger.
