US Application Serial No. 13/900,768 in turn claimed priority benefits in Provisional Application Serial No. 61/650,811 filed May 23, 2012 under the title **SPECTRAL, POLAR AND SPECTRAL-POLAR IMAGERS FOR USE IN SPACE SITUATIONAL AWARENESS**. This assignment applies to any and all applications identified above and any and all subsequent patent applications, domestic and/or foreign, claiming priority benefits in Provisional Application Serial No. 61/650,811, US Non-Provisional Application No. 13/900,768 and/or US Non-Provisional Application No. 15/824,661. (4) Each of the undersigned agrees to perform all affirmative acts that may be necessary to obtain a grant of valid patent(s) to the Assignee relating to the invention.


