
Assignor covenants that he or she has the full right to convey the interests assigned by this Assignment, and that he or she has not executed and will not execute any

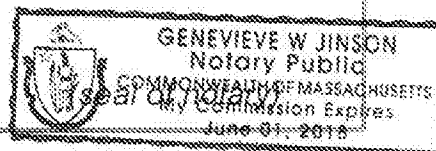

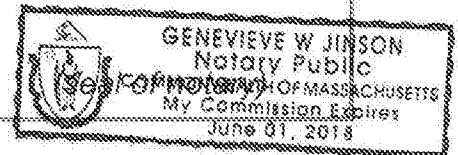


