## ASSIGNMENT

This Assignment is made and entered into by and between Kris R. Jatana and Charles A. 8. INVENTORS acknowledge and understand that they have had the opportunity to consult with independent legal counsel prior to executing this Assignment.

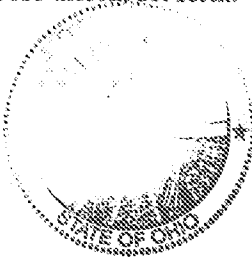

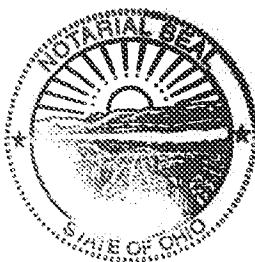
