

I further covenant and agree that I will, at any time upon request, do everything legally possible to aid Assignee, its successors, assignees, nominees, or other legal representatives to apply for, obtain, and enforce proper patent and/or utility model or design protection for said inventions in all countries, all without further consideration but at the expense of Assignee, its successors, assigns, nominees, or other legal representatives.

Assignor and Assignee hereby grants to the law firm of **GREENBERG TRAUERIG, LLP**, authority and power to insert on this instrument any further identification which may be necessary or desirable for purposes of recordation in the United States Patent Office or the Patent Office of any foreign country.
