The Assignors jointly developed an invention relating to "Selective Anti-Cancer Compounds" ("the Invention"), which has been filed as Patent Cooperation Treaty (PCT) Application No. PCT/SG2016/050269 on 10 June 2016 claiming priority from Singapore Patent Application No. 10201504656U on 12 June 2015 ("Patent Applications").
- B. The Assignors have previously agreed to assign and transfer to the Assignee all their rights, title and interests in the Invention and Patent Applications in all countries in the world ("the Territory") and that the Assignee should be substituted as the applicant in its place. In consideration of the sum of One Singapore dollar (S\$1) now paid by the Assignee to the Assignors, receipt of which the Assignors hereby acknowledge, the Assignors assign to the Assignee, free from all encumbrances, all right, title and interest in respect of the Invention and the Patent Applications, all divisions, continuations or reissues filed thereon, all patents granted thereon, and TOGETHER WITH their right to apply for and obtain patents or other similar forms of protection in respect of the Invention or any part or parts of the Invention in the Territory and the right to claim priority of the Patent Applications when making applications in the Territory TOGETHER WITH the right to bring proceedings for infringement in the Territory for any previous infringement TO HOLD the same unto the Assignee and its successors and assign absolutely.
- 2. The Assignors hereby covenant with the Assignee that the Assignors have the full right to convey the entire interest here assigned, have not done or knowingly suffered or been party or privy to any act or thing whereby the Assignors are prevented from assigning the Invention and the Patent Applications, and have not and will not execute any agreement in conflict herewith. The Assignors undertake they will not publish or disclose any particulars of the Invention and the Patent Applications to any person without the prior written consent of the Assignee.

At the request and cost of the Assignee, the Assignors shall execute all such documents and do all such acts as may be necessary to enable the Assignee or its successors, assigns, or other legal representatives to enjoy the full benefit of the rights confirmed and assigned by this Assignment including applying for and obtaining a patent or patents or other similar forms of protection in respect of the Invention in the Territory, vesting their right in the same in the Assignee when obtained, and testifying as to facts relating to the application and patents granted thereon in any litigation when requested to do so without further compensation, but at the expense of Assignee, its successors or other legal representatives.
