**RELEASE AND TERMINATION  
OF SECURITY INTEREST IN PATENT COLLATERAL**

THIS RELEASE AND TERMINATION OF SECURITY INTEREST IN PATENT COLLATERAL, dated as of December 8, 2017 (this “Release”), is made by **CRESCENT DIRECT LENDING, LLC**, a Delaware limited liability company, acting in its capacity as administrative agent (in such capacity, the “Administrative Agent”) under that certain Patent Security Agreement, dated as of October 14, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “Patent Security Agreement”), by and between **PETSTAGES, INC.**, an Illinois corporation with an address of 333 Skokie Blvd., Suites 102-104, Northbrook, IL 60062 (the “Grantor”) and the Administrative Agent.

WHEREAS, pursuant to the Patent Security Agreement which was recorded in the records of the United States Patent and Trademark Office on October 20, 2015 at reel 036831, frame 0397, the Grantor granted to the Administrative Agent a continuing security interest in all of the Grantor’s right, title and interest in, to and under its owned or thereafter acquired patents, including those set forth on the attached Schedule I (the “Patent Collateral”);

WHEREAS, pursuant to that certain Payoff Letter, dated as of December 7, 2017, by and between the Grantor, the other signatories party thereto and the Administrative Agent, the Grantor has requested and the Administrative Agent has agreed to (a) release any and all security interests it may have in the Patent Collateral pursuant to the Patent Security Agreement and (b) provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, relinquishment and discharge of its security interest in the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Patent Security Agreement in the Patent Collateral, (b) release and relinquish its security interest in the Patent Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Patent Collateral. The Administrative Agent agrees, or authorizes the Grantor, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Grantor to evidence the release and termination of the Administrative Agent’s security interests in the Patent Collateral.


