AND Assignors hereby request the Commissioner for Patents and Trademarks to issue said Letters Patent of the United States to Assignees, as Assignees of said inventions and

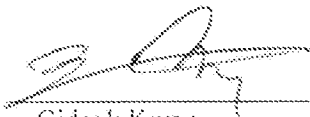
the Letters Patent to be issued thereon, for the sole use and benefit of Assignees, their successors, legal representatives and assigns.

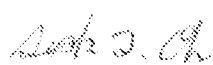
