## PATENT ASSIGNMENT AGREEMENT

This PATENT ASSIGNMENT AGREEMENT ("Agreement"), dated as of \_\_\_\_\_ ("Effective Date"), is made by Country View Medical Center d/b/a The Illinois Back Institute ("Assignor"), a corporation with a principal place of business at 1751 S. Naperville Road, Suite 107 Wheaton, IL 60189, in favor of Stella's Practice Management, LLC ("Assignee"), an Illinois limited liability company, located at 1751 S. Naperville Road, # 200 Wheaton, IL 60189.

WHEREAS, Assignor is the record owner of the entire right, title and interest in and to the patents and patent applications, set forth in Schedule I hereto, and the inventions disclosed or claimed therein, (collectively the "Assigned Patents"); and

WHEREAS, Assignee is desirous of acquiring, and Assignor is willing to convey, all worldwide right, title and interest in and to said Assigned Patents.

NOW THEREFORE, the parties agree as follows:

1. Assignment. For the consideration of the payment of One Dollar (\$1.00) and for other good and valuable consideration, the receipt and sufficiency are hereby acknowledged, Assignor hereby irrevocably conveys, transfers and assigns to Assignee, and Assignee hereby accepts, all of Assignor's worldwide right, title and interest in and to the Assigned Patents, including:

(a) the Assigned Patents set forth in Schedule I hereto and all issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations and renewals thereof, including and any and all foreign counterparts or legal equivalents of the Assigned Patents in any and all foreign countries, including the right to claim priority under any International Convention, and in and to any and all letters patent, design registrations or legal equivalents to be obtained for any of the inventions and designs disclosed or claimed in the Assigned Patents and/or any continuation, division, reissue, reexamination, renewal and/or substitute of said letters patent, applications, design registrations and/or legal equivalents therefor, in the United States of America and/or any and all foreign countries;

(b) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(c) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on and/or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Assignor hereby authorizes the Commissioner for Patents in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Agreement upon request by Assignee. Following the date hereof, upon Assignee's reasonable request, and at Assignee's sole cost and expense, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence or perfect the assignment of the Assigned Patents to Assignee, or any assignee or successor thereto.

3. Counterparts. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.

4. Successors and Assigns. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

5. Governing Law. This Agreement and any claim, controversy, dispute or cause of action (whether in contract, tort or otherwise) based upon, arising out of or relating to this Agreement and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Illinois, without giving effect to any choice or conflict of law provision or rule (whether of the State of Illinois or any other jurisdiction).

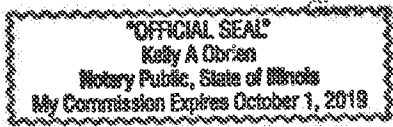

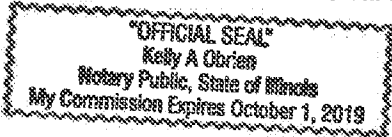
