PARTIAL RELEASE OF SECURITY INTEREST

This partial release of security interest (the "**Release**") is made and executed by Concert Debt, LLC, a Delaware limited liability company having a place of business at 20 Depot Street, Suite 2A, Peterborough, NH 03458 ("**Concert Debt**") in favor of Concert Technology Corporation, a Delaware corporation, and its wholly-owned subsidiaries Waldeck Technology, LLC, Domingo Enterprises, LLC, Porto Technology, LLC, and Cranbrook Technology, LLC, each Delaware limited liability companies having places of business at 20 Depot Street, Suite 2A, Peterborough, NH 03458 (Concert Technology Corporation, Waldeck Technology, LLC, Domingo Enterprises, LLC, Porto Technology, LLC, and Cranbrook Technology, LLC individually and collectively, referred to herein as "**Debtors**").

A. Waldeck Technology, LLC, Domingo Enterprises, LLC, Porto Technology, LLC, and Cranbrook Technology, LLC, each wholly-owned subsidiaries of Concert Technology Corporation, wish to sell a portion of its patents, patent applications, and related patents rights (collectively, the "**Released Patent Rights**") to a third party.

B. Upon assignment to Concert Debt of certain promissory notes evidencing debts of Debtors, Concert Debt amended the promissory notes to effect, among other things, an extension of the respective maturity dates of the promissory notes and was granted a security interest in certain collateral of Debtors pursuant to:

(a) a Security Agreement, effective May 1, 2015 with respect to certain of the assigned promissory notes and August 1, 2015 with respect to other of the assigned promissory notes (the "**Security Agreement**"), in certain Collateral (as defined in the Security Agreement) of Debtors, such Collateral including the Released Patent Rights;

such security interest to secure indebtedness and obligations of Debtors to Concert Debt, as evidenced by the promissory notes

C. Concert Debt recorded and/or filed its security interest as follows:

NOW, THEREFORE, for valuable consideration acknowledged and received by its execution of this Release, Concert Debt hereby irrevocably and unconditionally releases all right, title and interest in a portion of the Collateral owned by Waldeck Technology, LLC (and only such portion of the Collateral owned by Waldeck Technology, LLC, herein the "Released Collateral"), including:

(a) the patents and patent applications described in **Exhibit A** (the "Patents"), including, without limitation, all domestic and foreign patent applications and registrations therefor (and all patents that issue therefrom and all divisions, continuations, continuations-in-part, reexaminations, substitutions, reissues, extensions and renewals of such applications, registrations and patents, and the right to apply for any of the foregoing, and all pending and abandoned patent applications to which any of the Patents claim priority);

(b) all inventions, invention disclosures, and discoveries described in the Patents to the extent that such inventions, invention disclosures and discoveries could be claimed in any of the Patents;

(c) all patents that are related to any of the Patents through terminal disclaimer,

(d) all goodwill associated therewith;

(e) all rights to causes of action and remedies related thereto (including, without limitation, the right to sue for past, present or future infringement, misappropriation or violation of rights related to the foregoing and to retain any damages and profits due or accrued); and

(f) any and all other rights and interests arising out of, in connection with or in relation to the Patents.

If necessary or desired, Concert Debt hereby authorizes Debtors' authorized representative to file amendments to the UCC Financing Statements with the applicable filing offices and to record redacted copies of this Release (such redactions first approved by Concert Debt) in the United States Patent and Trademark Office to memorialize the release of any such security interest in the Released Collateral by Concert Debt.

This Release is governed by the law of the State of Delaware, excluding its choice of law principles to the contrary. This Release shall be binding upon Debtors and their successors and assigns and inures, to the benefit of, with respect to the Released Collateral (including any purchaser). Concert Debt acknowledges that it is aware that it may hereafter discover facts different from or in addition to what it now knows, believes or suspects to be true with respect to the matters herein released, that such facts may give rise to claims, causes of action, damages, consequences or results that are unforeseen or unsuspected, and that Concert Debt is nonetheless giving up its rights, and the releases in this Release will be and remain in effect in all respects as complete, general releases, notwithstanding any such different or additional facts.

This is a partial release only and does not release any collateral from said security interests, or other encumbrances or liens other than that specifically described above. Nothing in this Release shall in any way impair, alter or diminish the effect, security interest, lien or

encumbrance of the Security Agreement on the remaining part of the Collateral not specifically released therefrom or any of the rights and remedies contained therein.
