THIS RELEASE OF SECURITY INTERESTS IN PATENTS (this “Release”) is made as of November 7, 2017 (“Effective Date”) by ARES CAPITAL CORPORATION, a Maryland corporation, in its capacity as Agent (the “Agent”) for the Lenders in favor of YOUNG OS LLC, a Delaware Limited Liability Company, YOUNG MICROBRUSH, LLC, a Delaware Limited Liability Company, YOUNG INNOVATIONS, INC., a Missouri Corporation, YOUNG DENTAL MANUFACTURING, LLC, a Missouri Limited Liability Company, YOUNG PS ACQUISITIONS, LLC, a Delaware Limited Liability Company and AMERICAN EAGLE INSTRUMENTS, LLC, a Delaware Limited Liability Company (“Borrowers”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Amended and Restated Guarantee and Collateral Agreement (as defined below).

W I T N E S S E T H

WHEREAS, pursuant to that certain Second Lien Guarantee and Collateral Agreement, dated as May 30, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, including by joinder, the “Guarantee and Collateral Agreement”), among the Borrowers, the Agent, the Lenders (as defined in the Credit Agreement (as defined below)) and the other loan parties thereto, Borrowers has granted to Agent, for its benefit and the benefit of Lenders, a security interest and lien upon substantially all assets of Grantor, including all right, title and interest of Borrowers in, to and under all now owned and hereafter acquired Patents (as defined in the Guarantee and Collateral Agreement including any reissues or extensions thereof), together with all proceeds thereof, to secure the payment of all amounts owing by Borrowers pursuant to the terms and conditions set forth in the Second Lien Credit Agreement, dated as of May 30, 2014 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) among the Borrowers, Agent, the Lenders, and the other loan parties thereto;

WHEREAS, pursuant to the Guarantee and Collateral Agreement, the Borrowers as grantors (the “Grantors”) executed the Patent Security Agreement dated May 30, 2014 and the Amended and Restated Patent Security Agreements, dated as of May 3, 2017 (the “Patent Security Agreements”) and recorded with the U.S. Patent and Trademark Office on June 5, 2014 at Reel/Frame Nos. 033086/0181, 033086/0412, 033086/0435, 033086/0714, 033086/0907, and 033087/0081, and recored with the U.S. Patent and Trademark Office on May 3, 2017 at Reel/Frame No. 042262/0205, sent for recordal on September 29, 2017 and on October 9, 2017, pursuant to which the Grantors granted to Agent, as grantee, a security interest in, all of its right, title and interest in, to and under the Patent Collateral (as defined in the Patent Security Agreements), including those items set forth on Schedule I hereto; and

WHEREAS, Grantors have satisfied the terms of the Guarantee and Collateral Agreement and requests a specific release of the security interest granted and recorded against the Patent Collateral.

NOW, THEREFORE, pursuant to the terms of that certain payoff letter, dated as of the date hereof, by and among, the Agent, the Lenders, the Borrower and other parties thereto,

for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby, on behalf of itself and the Lenders, without recourse, representation, warranty or other assurance of any kind by the Agent (express or implied) as to the Agent's rights in any Patents, the condition or value of any Patents, (i) terminates the Patent Security Agreements and releases, discharges and cancels and re-assigns to each Grantor any and all liens, security interests, right, title and interest it may have in, to and under any and all Patent Collateral, including those items set forth on Schedule I hereto; (ii) agrees that it shall execute all other documents and do all other acts reasonably requested by each Grantor to relinquish and effect the release of such rights to such Grantor; and (iii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Agent's rights under the Guarantee and Collateral Agreement with respect to the Patent Collateral.
